

ORDINANCE NO. 2024-0813

AN ORDINANCE AMENDING ORDINANCE NO. 2022-0510 OF THE PLAINFIELD FIRE PROTECTION DISTRICT TO INCLUDE LIFT ASSIST/CITIZEN ASSIST CHARGES

WHEREAS, the Plainfield Fire District (the "District") is a fire protection district duly organized under the laws of the State of Illinois; and

WHEREAS, the Board of Trustees of the District has full power to pass all necessary ordinances, and rules and regulations for the proper management and conduct of the business of the Board of Trustees of the District for carrying into effect the objects for which the District was funded under 70 ILCS 705/6; and

WHEREAS, the Board of Trustees of the District has previously established ambulance and related charges in Ordinance No. 2022-0510; and

WHEREAS, the Board has determined that it is necessary to amend Ordinance No. 2022-0510 to insert a new charge for lift assists.

NOW, THEREFORE, BE IT ORDAINED by the Board of Trustees of the Plainfield Fire Protection District as follows:

Section 1. Ordinance No. 2022-0510 is amended to include the following language as its new Section 7:

"Section 7. In addition to the fees prescribed in Section 1 of this Ordinance, the District shall assess a \$100 charge for lift assists/citizen assists. The District shall only charge for lift assist/citizen assists after the sixth response call to the same address within the calendar year. Any such charges shall be a direct bill."

Section 2. The provisions of this Ordinance shall supersede any prior ordinances establishing charges which are inconsistent with this Ordinance. All unamended portions of Ordinance No. 2022-0510 are ratified and remain in full force and effect.

Section 3. This Ordinance shall be in full force and effect as of the date of passage.

Section 4. If any section, paragraph or provisions of this Ordinance shall be held invalid or unenforceable for any reason, such invalidity or unenforceability shall not affect any of the remaining provisions of this Ordinance.
